Key Peninsula Business Association Agenda ZOOM Meeting October 6, 2020, 6:30 PM

The meeting was held via Zoom with Tracey Perkosky from Key Pen Parks Department providing the Zoom session and Gina Cabiddu hosting the meeting. The meeting was called to order at 6:33 pm.

There were no new members or visitors to introduce.

Agenda Approval

The agenda was displayed for everyone to see and a motion was made by Frank Grubaugh and seconded by Jeff Minch to approve the agenda as is.

Board and Committee Reports

Secretary

The secretary advised there were no corrections or revisions received for the September Minutes that were sent to all members by e-mail. Frank Grubaugh made a motion to accept the September Minutes as submitted and Kevin Parr seconded.

Treasurer

Linda talked about the September Treasurer's Report stating we had available funds at the end of the month of \$6,396.75 and \$23,343.61 in the Money Market account. However, the money market account is now at zero as we have sent those funds to the Ruth Bramhall Nursing Endowment account at TCC. Gina thanked everyone that contributed to this accomplishment. Todd advised that an additional \$2500 was sent in previously to this account and he made sure that anyone donating directly to TCC made sure to mark the donation for the Ruth Bramhall Nursing Endowment. Todd asked for the outstanding bills left to be paid this year. Linda answered as far as she knew, the Christmas ad in the Key Pen News and the only firm item, but the budget has funds allocated for the Peninsula Schools Education Foundation where we buy a table for the breakfast. However, she is not sure if this has been cancelled. Gina will find out the status of this event and advise the membership. Todd Rosenbach made a motion to accept the Treasurer's Report and Danna Webster seconded.

Ruth's Donation Committee

The status was given with the Treasurer's Report and Gina again commented what a great effort this was and would help nursing students for generations to come. A motion was made by Danna Webster to approve all the discussion on Ruth's donation committee and was seconded by Jeff Minch.

Events & Committees

Gina created a survey and sent out via Survey monkey to solicit suggestions from the membership on how to support the community with the funds that were made available in our budget by moving funds around with the Covid-19 revisions. So far, 12 responses have been received. The survey is open until October 16, and results will be available at the lunch meeting on that day.

Mark Cockerill mentioned the KPC has purchased a one-year contract with Survey Monkey as part of the Broadband project. KPC is making this subscription available for use by other groups and is available to help set up and administer these surveys.

Danna advised scarecrow contest is using on-line voting and it is proving to be successful. The turnout for this contest has been fabulous.

Students coming to Red Barn to work in a pod have transportation, food and support for their class work and socializing. We are looking to expand this model at Chapel Hill Church in Gig Harbor. Mark at Community Council has been helpful. Still giving backpacks and school supplies for students that need them. We have provided these items for 204 students. Rental assistance has been through the roof, and we are delivering diapers where needed as they are not covered by assistance programs. Have been trained now in FMLA. Very busy time for us.
